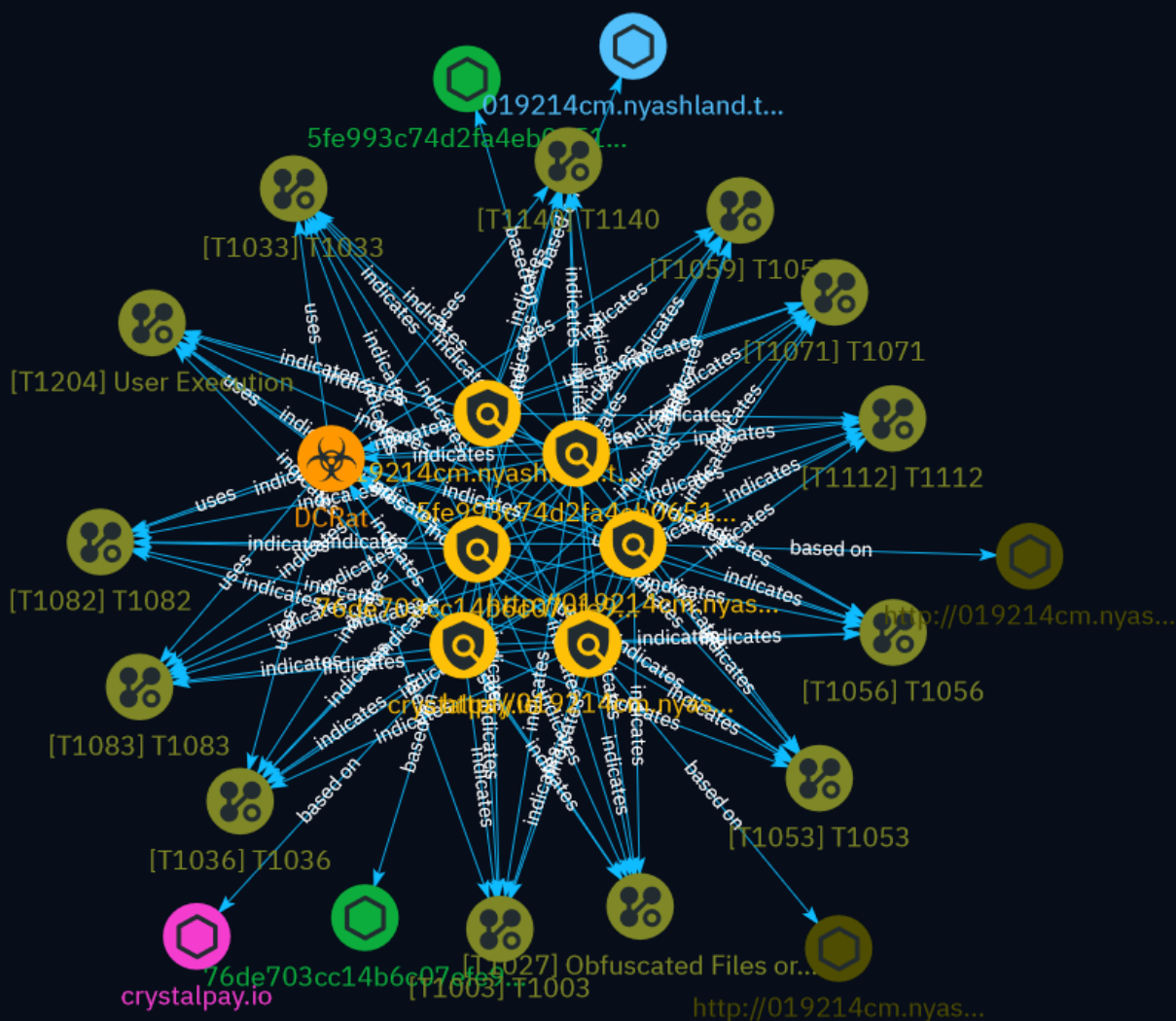

Description

Adversaries may use methods of capturing user input to obtain credentials or collect information. During normal system usage, users often provide credentials to various different locations, such as login pages/portals or system dialog boxes. Input capture mechanisms may be transparent to the user (e.g. [Credential API Hooking](https://attack.mitre.org/techniques/T1056/004)) or rely on deceiving the user into providing input into what they believe to be a genuine service (e.g. [Web Portal Capture](https://attack.mitre.org/techniques/T1056/003)).

Description

Adversaries may enumerate files and directories or may search in specific locations of a host or network share for certain information within a file system. Adversaries may use the information from [File and Directory Discovery](<https://attack.mitre.org/techniques/T1083>) during automated discovery to shape follow-on behaviors, including whether or not the adversary fully infects the target and/or attempts specific actions. Many command shell utilities can be used to obtain this information. Examples include `dir``, `tree``, `ls``, `find``, and `locate``.(Citation: Windows Commands JPCERT) Custom tools may also be used to gather file and directory information and interact with the [Native API](<https://attack.mitre.org/techniques/T1106>). Adversaries may also leverage a [Network Device CLI](<https://attack.mitre.org/techniques/T1059/008>) on network devices to gather file and directory information (e.g. `dir``, `show flash``, and/or `nvram``). (Citation: US-CERT-TA18-106A)

Description

Adversaries may abuse command and script interpreters to execute commands, scripts, or binaries. These interfaces and languages provide ways of interacting with computer systems and are a common feature across many different platforms. Most systems come with some built-in command-line interface and scripting capabilities, for example, macOS and Linux distributions include some flavor of [Unix Shell](<https://attack.mitre.org/techniques/T1059/004>) while Windows installations include the [Windows Command Shell](<https://attack.mitre.org/techniques/T1059/003>) and [PowerShell](<https://attack.mitre.org/techniques/T1059/001>). There are also cross-platform interpreters such as [Python](<https://attack.mitre.org/techniques/T1059/006>), as well as those commonly associated with client applications such as [JavaScript](<https://attack.mitre.org/techniques/T1059/007>) and [Visual Basic](<https://attack.mitre.org/techniques/T1059/005>). Adversaries may abuse these technologies in various ways as a means of executing arbitrary commands. Commands and scripts can be embedded in [Initial Access](<https://attack.mitre.org/tactics/TA0001>) payloads delivered to victims as lure documents or as secondary payloads downloaded from an existing C2. Adversaries may also execute commands through interactive terminals/shells, as well as utilize various [Remote Services](<https://attack.mitre.org/techniques/T1021>) in order to achieve remote Execution.

Obfuscated Files or Information

Description

Adversaries may attempt to make an executable or file difficult to discover or analyze by encrypting, encoding, or otherwise obfuscating its contents on the system or in transit. This is common behavior that can be used across different platforms and the network to evade defenses. Payloads may be compressed, archived, or encrypted in order to avoid detection. These payloads may be used during Initial Access or later to mitigate detection. Sometimes a user's action may be required to open and [Deobfuscate/Decode Files or Information](<https://attack.mitre.org/techniques/T1140>) for [User Execution](<https://attack.mitre.org/techniques/T1204>). The user may also be required to input a password to open a password protected compressed/encrypted file that was provided by the adversary. (Citation: Volexity PowerDuke November 2016) Adversaries may also use compressed or archived scripts, such as JavaScript. Portions of files can also be encoded to hide the plain-text strings that would otherwise help defenders with discovery. (Citation: Linux/Cdorked.A We Live Security Analysis) Payloads may also be split into separate, seemingly benign files that only reveal malicious functionality when reassembled. (Citation: Carbon Black Obfuscation Sept 2016) Adversaries may also abuse [Command Obfuscation](<https://attack.mitre.org/techniques/T1027/010>) to obscure commands executed from payloads or directly via [Command and Scripting Interpreter](<https://attack.mitre.org/techniques/T1059>). Environment variables, aliases, characters, and other platform/language specific semantics can be used to evade signature based detections and application control mechanisms. User Execution

Description

An adversary may rely upon specific actions by a user in order to gain execution. Users may be subjected to social engineering to get them to execute malicious code by, for example, opening a malicious document file or link. These user actions will typically be observed as follow-on behavior from forms of [Phishing](https://attack.mitre.org/techniques/T1566). While [User Execution](https://attack.mitre.org/techniques/T1204) frequently occurs shortly after Initial Access it may occur at other phases of an intrusion, such as when an adversary places a file in a shared directory or on a user's desktop hoping that a user will click on it. This activity may also be seen shortly after [Internal Spearphishing](https://attack.mitre.org/techniques/T1534). Adversaries may also deceive users into performing actions such as enabling [Remote Access Software](https://attack.mitre.org/techniques/T1219), allowing direct control of the system to the adversary, or downloading and executing malware for [User Execution](https://attack.mitre.org/techniques/T1204). For example, tech support scams can be facilitated through [Phishing](https://attack.mitre.org/techniques/T1566), vishing, or various forms of user interaction. Adversaries can use a combination of these methods, such as spoofing and promoting toll-free numbers or call centers that are used to direct victims to malicious websites, to deliver and execute payloads containing malware or [Remote Access Software](https://attack.mitre.org/techniques/T1219). Description

Adversaries may interact with the Windows Registry to hide configuration information within Registry keys, remove information as part of cleaning up, or as part of other techniques to aid in persistence and execution. Access to specific areas of the Registry depends on account permissions, some requiring administrator-level access. The built-in

Windows command-line utility [Reg](<https://attack.mitre.org/software/S0075>) may be used for local or remote Registry modification. (Citation: Microsoft Reg) Other tools may also be used, such as a remote access tool, which may contain functionality to interact with the Registry through the Windows API. Registry modifications may also include actions to hide keys, such as prepending key names with a null character, which will cause an error and/or be ignored when read via [Reg](<https://attack.mitre.org/software/S0075>) or other utilities using the Win32 API. (Citation: Microsoft Reghide NOV 2006) Adversaries may abuse these pseudo-hidden keys to conceal payloads/commands used to maintain persistence. (Citation: TrendMicro POWELIKS AUG 2014) (Citation: SpectorOps Hiding Reg Jul 2017) The Registry of a remote system may be modified to aid in execution of files as part of lateral movement. It requires the remote Registry service to be running on the target system. (Citation: Microsoft Remote) Often [Valid Accounts](<https://attack.mitre.org/techniques/T1078>) are required, along with access to the remote system's [SMB/Windows Admin Shares](<https://attack.mitre.org/techniques/T1021/002>) for RPC communication.

Description

Adversaries may attempt to manipulate features of their artifacts to make them appear legitimate or benign to users and/or security tools. Masquerading occurs when the name or location of an object, legitimate or malicious, is manipulated or abused for the sake of evading defenses and observation. This may include manipulating file metadata, tricking users into misidentifying the file type, and giving legitimate task or service names. Renaming abusible system utilities to evade security monitoring is also a form of [Masquerading](<https://attack.mitre.org/techniques/T1036>). (Citation: LOLBAS Main Site) Masquerading may also include the use of [Proxy](<https://attack.mitre.org/techniques/T1090>) or VPNs to disguise IP addresses, which can allow adversaries to blend in with normal network traffic and bypass conditional access policies or anti-abuse protections.

Description

Adversaries may use [Obfuscated Files or Information](<https://attack.mitre.org/techniques/T1027>) to hide artifacts of an intrusion from analysis. They may require separate mechanisms to decode or deobfuscate that information depending on how they intend to use it. Methods for doing that include built-in functionality of malware or by using utilities present on the system. One such example is the use of [certutil](<https://attack.mitre.org/software/S0160>) to decode a remote access tool portable executable file that has been hidden inside a certificate file.(Citation: Malwarebytes Targeted Attack against Saudi Arabia) Another example is using the Windows `copy /b`` command to reassemble binary fragments into a malicious payload.(Citation: Carbon Black Obfuscation Sept 2016) Sometimes a user's action may be required to open it for deobfuscation or decryption as part of [User Execution](<https://attack.mitre.org/techniques/T1204>). The user may also be required to input a password to open a password protected compressed/encrypted file that was provided by the adversary. (Citation: Volexity PowerDuke November 2016)

Description

Adversaries may abuse task scheduling functionality to facilitate initial or recurring execution of malicious code. Utilities exist within all major operating systems to schedule programs or scripts to be executed at a specified date and time. A task can also be scheduled on a remote system, provided the proper authentication is met (ex: RPC and file and printer sharing in Windows environments). Scheduling a task on a remote system typically may require being a member of an admin or otherwise privileged group on the remote system.(Citation: TechNet Task Scheduler Security) Adversaries may use task scheduling to execute programs at system startup or on a scheduled basis for persistence.

These mechanisms can also be abused to run a process under the context of a specified account (such as one with elevated permissions/privileges). Similar to [System Binary Proxy Execution](<https://attack.mitre.org/techniques/T1218>), adversaries have also abused task scheduling to potentially mask one-time execution under a trusted system process. (Citation: ProofPoint Serpent)

Description

An adversary may attempt to get detailed information about the operating system and hardware, including version, patches, hotfixes, service packs, and architecture. Adversaries may use the information from [System Information Discovery](<https://attack.mitre.org/techniques/T1082>) during automated discovery to shape follow-on behaviors, including whether or not the adversary fully infects the target and/or attempts specific actions. Tools such as [Systeminfo](<https://attack.mitre.org/software/S0096>) can be used to gather detailed system information. If running with privileged access, a breakdown of system data can be gathered through the `systemsetup` configuration tool on macOS. As an example, adversaries with user-level access can execute the `df -aH` command to obtain currently mounted disks and associated freely available space. Adversaries may also leverage a [Network Device CLI](<https://attack.mitre.org/techniques/T1059/008>) on network devices to gather detailed system information (e.g. `show version`). (Citation: US-CERT-TA18-106A) [System Information Discovery](<https://attack.mitre.org/techniques/T1082>) combined with information gathered from other forms of discovery and reconnaissance can drive payload development and concealment. (Citation: OSX.FairyTale)(Citation: 20 macOS Common Tools and Techniques) Infrastructure as a Service (IaaS) cloud providers such as AWS, GCP, and Azure allow access to instance and virtual machine information via APIs. Successful authenticated API calls can return data such as the operating system platform and status of a particular instance or the model view of a virtual machine. (Citation: Amazon Describe Instance)(Citation: Google Instances Resource)(Citation: Microsoft Virtual Machine API)

Description

Adversaries may communicate using OSI application layer protocols to avoid detection/network filtering by blending in with existing traffic. Commands to the remote system, and often the results of those commands, will be embedded within the protocol traffic between the client and server. Adversaries may utilize many different protocols, including those used for web browsing, transferring files, electronic mail, or DNS. For connections that occur internally within an enclave (such as those between a proxy or pivot node and other nodes), commonly used protocols are SMB, SSH, or RDP.

Description

Adversaries may attempt to dump credentials to obtain account login and credential material, normally in the form of a hash or a clear text password, from the operating system and software. Credentials can then be used to perform [Lateral Movement](<https://attack.mitre.org/tactics/TA0008>) and access restricted information. Several of the tools mentioned in associated sub-techniques may be used by both adversaries and professional security testers. Additional custom tools likely exist as well.

Description

Adversaries may attempt to identify the primary user, currently logged in user, set of users that commonly uses a system, or whether a user is actively using the system. They may do this, for example, by retrieving account usernames or by using [OS Credential Dumping] (<https://attack.mitre.org/techniques/T1003>). The information may be collected in a number of different ways using other Discovery techniques, because user and username details are prevalent throughout a system and include running process ownership, file/directory ownership, session information, and system logs. Adversaries may use the information from [System Owner/User Discovery] (<https://attack.mitre.org/techniques/T1033>) during automated discovery to shape follow-on behaviors, including whether or not the adversary fully infects the target and/or attempts specific actions. Various utilities and commands may acquire this information, including ``whoami``. In macOS and Linux, the currently logged in user can be identified with ``w`` and ``who``. On macOS the ``dscl . list /Users | grep -v '_`` command can also be used to enumerate user accounts. Environment variables, such as ``%USERNAME%`` and ``$USER``, may also be used to access this information. On network devices, [Network Device CLI] (<https://attack.mitre.org/techniques/T1059/008>) commands such as ``show users`` and ``show ssh`` can be used to display users currently logged into the device. (Citation: `show_ssh_users_cmd_cisco`) (Citation: US-CERT TA18-106A Network Infrastructure Devices 2018)
